Above stated fines reflect the amount of violation if paid out of court at the Violation Bureau on or before the original court date. Payment by way of the Violations Bureau shall constitute a guilty plea and the waiver of a trial. In court, the Judge may assess a fine from \$1.00 to \$1,000.00 and up to ninety (90) days in jail for each violation. **Any citation involving an accident must appear in Court.** Pursuant to Section 135.180 of the city code, costs include a \$12.00 court cost, \$7.50 Crime Victims Fee, \$1.00 Post Training Fund, \$2.00 Police Training Fund, \$2.00 Domestic Violence Shelter, and \$2.00 Inmate Security Fund.

There will be a \$25.00 service fee on all returned checks
