The special meeting of the Board of Aldermen of the City of Town and Country was held at 6:00 P.M. on October 14, 2019, at the Municipal Center, 1011 Municipal Center Drive.

ROLL CALL

The 6:14 PM roll call indicated Aldermen Allen, Benigas, Butler, Frautschi, Holman, and Reuter were present. Alderman Mortland was absent. Mayor Dalton presided. Attorney Steven Garrett represented the City.

NEW BUSINESS

APPOINTMENT AND VOTE TO FILL ALDERMAN VACANCY IN WARD 1

Mayor Dalton nominated Jon Serkes to fill the unexpired term of Skip Mange.

Alderman Holman moved for approval of the Mayor's appointment, seconded by Alderman Allen.

Mayor Dalton provided a brief background of Mr. Serkes and noted that he was able to meet with all but one alderman.

Alderman Benigas moved to continue the consideration of Mr. Serkes' appointment to a special meeting on October 28, 2019 at 6:00 PM, seconded by Alderman Butler.

The roll call vote was: AYE, Aldermen Benigas, Butler, Frautschi, and Reuter; NAY, Allen and Holman; ABSTAIN, none; ABSENT, Mortland.


The motion to continue carried 4-2.
